The Texas Legislature has added a chapter to the Civil Practice and Remedies Code to limit liabilities for equine activities, effective September 1, 1995.

Chapter 87 of the code says there is no liability for property damage or damages arising from personal injury or death of a participant in an equine activity, if the damage or injury results from a risk inherent in equine activities. Inherent risks include collisions with other animals, certain surface conditions, and the unpredictability of an animal's reaction to certain stimuli and potential of a participant to act in a negligent manner contributing to an injury.

I hereby understand that Wood County Cowboy Church, Quitman, Texas and Cross Brand Cowboy Church of Tyler, Texas, it's members, and all other persons and organizations connected with these Churches or Arena are not to be held responsible for any injuries which I or my horse may incur while participating in any activities between January 1, 2014 through December 31, 2014 on the church property or in the arena at 3435 FM 2088, Quitman, Texas or as a result thereof.
